At the outset of the meeting the Deputy Commissioner, Morigaon welcomed all the members present.

1. Initiating the proceeding the Deputy Commissioner, Morigaon gave oath / affirmation to all the elected members of General Council as required under Rule 85(1) of Tiwa Autonomous Council (Election) Rule 2005 as authorized.
2. After taking of oath / affirmation by the elected members, the Deputy Commissioner Morigaon invited the members of the General Council to elect one amongst themselves as Protempore Chairman of the meeting to conduct the proceedings. Accordingly Smt. Rina Pator an elected member from 13 No. Nelie Khala (ST) Constituency has been proposed as Protempore Chairman by Shri Ramakanta Dewri an elected member from 18 No. Charipunia Chabukdhara (ST) Constituency which has been seconded by Sri Madan Bordoloi an elected member of 31 No. Lalungpar (ST) Constituency. As only one candidate has been duly proposed and seconded, hence Smt. Rina Pator has been declared elected as Protempore Chairperson.
3. After Election of Protempore Chairperson she took the chair and initiated conduct further proceeding of the meeting.

4. The presiding officer thereafter invited the Members of the General Council to elect one amongst themselves as Chairman of General Council. Smt. Rina Pator an elected member from 13 No. Nelie Khala constituency has been proposed as chairman of General Council by Smt. Monorama Bordoloi, an elected member from 8 No. Ghagua Constituency which has been seconded by Shri Ramakanta Dewri an elected member of 18 No. Charipunia Chabukdhara constituency. As only one candidate has been duly proposed and seconded, hence Smt. Rina Pator has been declared elected as Chairperson.
5. The presiding officer thereafter invited the Members of the General Council to elect one amongst themselves as Deputy Chairman of General Council. Shri Khagen Bordoloi an elected member from 10 No. Tetelia constituency has been proposed as Deputy Chairman of General Council by Dipali Boro an elected member from 11 No. Junbeel Constituency which has been seconded by Sri Bijumoni Bordoloi an elected member of 27 No. Kaki constituency. Further Sri Haren Dewri an elected member from 29 No. Kamargaon constituency has been proposed as Deputy Chairman of General Council by Sri Sukleswari Bordoloi an elected member from 30 No. Nambor Lalung Constituency which has been seconded by Sri Suruj Konwar an elected member of 21 No. Topakuchi constituency. As more than one candidate i.e. two candidates have been proposed and seconded for Election of Deputy Chairman of General Council, the Presiding Officer arranged for election of Deputy Chairman through voting as per Rule 119 of said Rules and since votes secured by the candidate is equal i.e. 15, hence by drawing of lots Shri Haren Dewri has been declared elected as Deputy Chairman.
6. The presiding officer thereafter invited the Members of the General Council to elect one amongst themselves as Chief Executive Councilor of Executive Council. Sri Khiren Chandra Bordoloi, an elected member from 17 No. Bhumuraguri constituency has been proposed as Chief Executive Councilor of Executive Council by Sri Pranabjyoti Masrang an elected member from 24 No. Jongbalahu Constituency which has been seconded by Shri Niraj Bordoloi an elected member of 9 No. Damal Constituency. Further Shri Ramakanta Dewri an elected member from 18 No. Charipunia Chabukdhara constituency has been proposed as Chief Executive Councilor of Executive Council by Sri Saruj Konwar an elected member from 21 No. Topakuchi Constituency which has been seconded by Sri Ankurjyoti Borah an elected member of 23 No. Jorabari constituency. As more than one candidate i.e. two candidates have been proposed and seconded for Election of Chief Executive Councilor of Executive Council, the Presiding Officer arranged for election of Chief Executive Councilor of Executive Council through voting as per Rule 119 of said Rules. As Shri Ramakanta Dewri got the largest number of valid votes i.e. 16 (sixteen) nos. of vote against the other candidate Sri Khiren Chandra Bordoloi 14 (fourteen) nos. of votes, accordingly Shri Ramakanta Dewri has been declared elected as Chief Executive Councilor of Executive Council.
7. The presiding officer thereafter invited the Members of the General Council to elect one amongst themselves as Deputy Chief Executive Councilor of Executive Council. Sri Bipin Ch. Bordoloi an elected member from 1 No. Jamadari Constituency has been proposed as Deputy Chief Executive Councilor of Executive Council by Sri Bubul Ch. Patar an elected member from 6 No. Manipur Constituency which has been seconded by Shri Dharmendra Nath Bordoloi an elected member of 19 No. Borchila Constituency. As only one candidate has been duly proposed and seconded, hence Sri Bipin Ch. Bordoloi has been declared elected as Deputy Chief Executive Councilor of Executive Council.
8. The presiding officer thereafter invited the Members of the General Council to elect Executive Councilor of Executive Council amongst themselves.
9. Sri Niraj Bordoloi an elected member from 9 No. Damal constituency has been proposed as Executive Councilor of Executive Council by Sri Bipin Ch. Bordoloi an elected member from 1 No. Jamadari Constituency which has been seconded by Shri Bubul Ch. Pator an elected member of 6 No. Manipur constituency. As Shri Niraj Bordoloi has been duly proposed and seconded and accepted by all the members as the first Executive Councilor hence Shri Niraj Bordoloi has been declared elected as Executive Councilor of Executive Council.

10. The General Council has decided to elect other Executive Councilor of the Executive Council in the light of provision under Rule 118(3)(e) of the Tiwa Autonomous Council (Election) 2005 in due course of time.

After the completion of the proceeding the Deputy Commissioner, Morigaon expressed her thanks to all present in the meeting for smooth conduct of proceedings. The meeting ended with vote of thanks from the Chair.
